There were good reasons to change to the new version 1. Good Practice 2. Security Issues 3. Word Press may stop supporting the old version 4. Cllr Thring being competent with new version. Cllr Thring had investigated changing to the new version and had been told by the web provider this would could be done but would probably mean that the web site would need reconfiguring at a cost of £250.00.
